- Entries not on official AKC Entry forms and photocopies of entry forms without Agreement and Rules attached are not acceptable.
- ENTRIES WITHOUT ATTACHED CHECK funds are not a valid entry. Postdated or returned Checks do not constitute a valid entry fee. There will be a \$35 service fee for any returned check.
- ERRORS ON ENTRY FORMS are the responsibility of the owners and no entry fee will be refunded after published closing date. PLEASE submit all information about dog, including sire/dam when known. For inclusion in the catalog, please list ALL AKC titles earned by the dog.
- No Entry will be accepted which specifies any condition as to its acceptance.
- The Club assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT. (Requirements for completeness of entry are found [http://images.akc.org/pdf/rulebooks/RO2999\\_0318.pdf](http://images.akc.org/pdf/rulebooks/RO2999_0318.pdf) page 8-9). Full registered name of dog includes ALL AKC titles.
- CONFIRMATION OF ENTRY: Confirmation and judging program will be e-mailed to the address listed on the official AKC Entry Form. Hard copy by written request only.
- MIXED BREED DOGS that have been listed with AKC Canine Partners may participate provided their listing numbers have been recorded on the entry form. **Sire and Dam information shall remain blank for mixed breed entrants.**

### A NOTE ON TRANSFERS

Any request for transfers prior to the trial weekend **must be received by the Trial Secretary by 11:59 p.m. on SUNDAY, AUGUST 24th, 2025** There will be **NO same-day transfers** between the two Saturday trials. There *will* be next-day transfers between Saturday's trials and the Sunday trial. Any request for transfer must be received by the Trial Secretary **no later than 30 minutes after the last dog completes the second trial on Saturday.**

### NON-REGULAR CLASSES

**Rally Pairs Class.** Rally Pairs class consists of a handler working two dogs at one time through a rally course. The courses will be designed as stated for each level, except there will not be any jumps in any class levels in the Pairs class. A club may offer any non-regular class levels without having to offer all levels and all dogs are eligible to enter any class level.

**Pairs Scoring.** Scores will be based on a possible 200 points, with ties being broken by time. All signs will be counted with a point value. The maximum point value that can be deducted at any one sign will be 10 points per dog (20 total points). There will not be any NQ's awarded for a performance. It is possible for a team to receive a negative score. All other rally rules and regulations will apply for each class level offered as a non-regular class.

**Rally Team Competition.** The Rally Team Competition will be for teams of any four dogs that are eligible under these Regulations. Five dogs may be entered, one to be considered an alternate for which no entry fee will be required; however, the same four dogs will perform all of the signs. No dog may be entered on more than one team. There is a total possible score of 400 points for each team. All team members will run the course individually, with the team time running continuously. Time will start when the judge gives the first member of the team the forward command from the "Start" sign. The subsequent dog for each team starts when the previous

handler for the team passes the “Finish” sign without an additional command of “Forward” by the judge. Timing for each team will begin when the judge commands the first handler in the team to begin with the command “Forward” and will stop when the fourth handler from the team passes the finish sign. If jumps are required, they will be based on the height of the smallest dog on each competing team.

**Team Scoring.** All signs will be counted with a point value. The maximum point value that can be deducted at any one sign will be 10 points. It is possible for a team to receive a negative score.

- The GRAND FORKS DOG TRAINING CLUB., THE TRIAL SECRETARY, the TRIAL SITE, THEIR AGENTS, EMPLOYEES, ETC. and AKC assume no responsibility for any loss, damage, injury, or death sustained by exhibitors, handlers, or to any of their dogs or property, and assumes no responsibility for injury to children not under control of their parent(s) or guardian(s) and assume no responsibility for any loss, damage or injury sustained by spectators, exhibitors, handlers, their employees or children, etc., or to any of their dogs or property. Entrants and spectators to this show do so entirely at their own risk.
- THIS SHOW IS GOVERNED BY THE AMERICAN KENNEL CLUB. Exhibitors should read the AKC agreement on the entry.
- THIS CLUB DOES AGREE TO ARBITRATE CLAIMS as set forth on the Official AKC Entry form for these events.
- Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. There will be no refunds of entry fees if a person is asked to leave the trial site.
- All dogs must be held on leash or crated at all times when not in the ring or in the designated warm-up area.
- Crates may be left overnight; however, the Grand Forks Dog Training Club and the trial site will not be responsible for any lost or damaged items left at the show site. No dogs may remain in the building after the end of the trial each day.
- Exhibitors should follow their veterinarians’ recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- Please keep walkways and aisles clear at all times under the orders of local Fire Marshall. This is a non-smoking building and no alcoholic beverages are allowed on the trial site.
- The AKC is committed to creating a safe and respectful sport environment for all. If you need to talk to someone or need help, please call 800-656-HOPE (National Sexual Assault Hotline) or text HOME to 741-741 for free, 24/7, confidential services from trained crisis counselors.

## **REFUNDS**

- Bitches in season are not permitted in the Trial. Full entry fee will be refunded for bitches in season. Entry fees, less \$6 administrative fee per day, will be refunded for dogs that become sick or injured after the closing date. Owner must present signed letter from veterinarian to trial secretary prior to start of show.
- If, because of riots or civil disturbances or other acts beyond the control of the management, it is impossible to open or to complete the trial, no refund of entry will be made.
- ENTRY FEES WILL NOT BE REFUNDED in the event that a dog is absent, disqualified, excused by a Veterinarian at the trial or Judge or barred from competition by act of the Show Committee.
- GFDTC reserves the right to cancel these trials in the event of extreme weather conditions and no entry fee refunds will be made in such case.
- Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, exhibitors and spectators.

The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

**RINGSIDE**

- Dogs may arrive any time prior to judging. All dogs not needed for further judging will be excused.
- Judges are not required to wait for dogs. Exhibitors alone are responsible for being at the ring gate when it is their turn to run.
- Digital Photographs or videos may be taken and used by the trial giving club, your attendance at this event constitutes your permission to use your and /or your dog’s images.

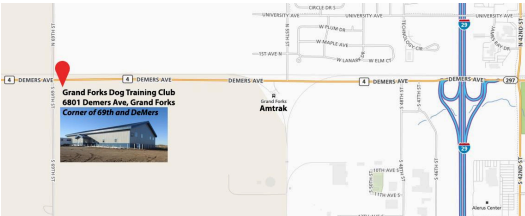
